WHEN PEGGY SUE CAME TO SANTA ROSA HIGH

In 1985, Peggy Sue Bodell attended her twenty fifth high school reunion at Santa Rosa High. Only Peggy Sue was really actress Kathleen Turner, and SRHS was the fictitious Buchanan High School. The movies had come to SRHS, led by filmmaking master Francis Coppola.

became Coppola's biggest hit since "Apocalypse Now," and garnered three Academy Award nominations.

Coppola filmed "Peggy Sue" entirely in Santa Rosa and Petaluma. He used SRHS, with its distinctive and classical architecture, for key scenes that included the pivotal



Coppola had epic triumphs in the 70s: "The Godfather," "The Godfather II," and "Apocalypse Now." But by the mid-80s, some began to wonder how much gas he had left in the tank. "Peggy Sue Got Married" dispelled the doubters when it was released in 1986. The sweet and funny story of an early middle aged woman's travels back through time to her high school years

twenty fifth reunion, and several 1960's classroom sequences. The production company paid for a complete restoration of the school's aging gothic façade. It even repaired and replaced the many gargoyle features.

"Peggy Sue" began filming on August 19, 1985 and ended in the third week of October. The production never disrupted the

Mr. Coppola: Staging a 1985 high school reunion in the gymnasium with Marshall Crenshaw and his band -- for several days.

Foundation: Did Kathleen Turner, Nick Cage, and up-andcomer Jim Carrey enjoy their time at Santa Rosa High and other local locations?

Mr. Coppola: "Peggy Sue" was in general, an enjoyable project for all of us.

President's Message

It is my pleasure to be serving a second two-year term as President of the SRHS Foundation. The current fiscal year, ending June 30, 2016, is the final year of my term. My goal is to continue the success and gratifying accomplishments the Foundation has achieved since its creation in 1988.



I wish to address a few changes that the Foundation has implemented since the completion of a financial audit on June 5, 2015 (for the fiscal year ending [FYE] June 30, 2014.) Additionally I wish to highlight the Foundation's financial status as of FYE June 30, 2015. Finally some highlights of the Foundation's activities and opportunities for you to be involved.

Because of the donation of over \$2.1 million from the James Fleck Trust ('46), the Foundation was required to have a financial audit for the FYE June 30, 2014. On June 5, 2015, the Foundation received the final audit from our CPA auditors with an "Unqualified Opinion". What this means is that auditors didn't find any exceptions to the Foundation being in conformance with Generally Accepted Accounting Principles. As proud as we are with the audit results, we did find some policies and procedures that the Foundation decided to update or change.

Some of the policies and procedures changed are as follows:

The Foundation reclassified and restructured some of the scholarship/memorials endowments to indicate that they are restricted, temporarily restricted or unrestricted funds. Additionally we restructured the process of no longer allowing the donor/contributor to make a final selection of the student/recipient of scholarships, awards or grants from the Foundation. These changes had no financial impact to the balance sheet. But the Foundation now recognizes endowed investments at current market value. In the past we had booked the value at its original value. This accounting change does have an impact on the Foundation's financial statements. These policies and procedures are reflected in both FYE statements ending June 30, 2014 and 2015. As a result of the accounting change the Foundation showed an unrealized loss for FYE June 30, 2015 of \$108 thousand.

The Foundation has been successful in increasing the generation of annual funds. An overview of the revenues

generated from the Golf Tournament and Polenta Feed reflects a 19% increase to \$50 thousand from the prior year events. The "One Thousand Panther" (OTP) donations increased from the prior year by 15% to \$44 thousand. The annual general contributions reflect an increase of 12% over the prior year to \$29 thousand. The membership and life membership had a 9% loss of \$3 thousand. The Foundation is seeing a decline in individuals renewing their memberships, but the Membership Committee is making strides to reverse this trend.

The Foundation's "Panther Project Fund" had its first meeting for this school year and received 14 requests for funding presented by various teachers. I'm excited to report the Foundation will be funding the vast majority of these requests, which enhance the under-funded programs at SRHS. None of this would happen without the support of the extremely motivated volunteer Board of Directors, your continued support as members of the Foundation, your contributions and your attendance at the Foundation's two fund raising events: the Golf Tournament and the Polenta Feed.

The 20th annual Golf Tournament, took place Sept 11, 2015. Again, the classy tournament and dinner was a huge success. This year's Polenta Feed will be held April 22, 2016. It is always very successful and considered a premiere "All Class Reunion."

In closing I am excited about the Foundation's role in the 2015/2016 school year. Please visit our web page at www.srhs.org to stay abreast of coming events and activities. Please continue to support our many fundraising efforts. Please encourage your friends and classmates to get involved. Remember, "Once a Panther Always a Panther".



Dan Lazzarini '64, had the good fortune of working as an assistant set decorator on the production. His previous work as a projectionist at local movie theaters had allowed him to join the I.A.T.S.E., a film, and theater union that covers many crafts. He recalls the director needing a period typewriter. His wife, Pauline, just happened to have one. So Dan sold it to the production for 50 bucks. He also remembers a rubber faced supporting actor who kept everyone in stitches between takes. That actor hadn't yet become a super star. His name was Jim Carrey.

Mike Daniels '59 and a SRHS instructor was on the set when he mentioned that he'd fallen asleep during Kathleen Turner's steamy "Body Heat." He turned around in time to see Ms. Turner, three feet away. She snorted, pivoted, and walked off.

But when a production person came to ask Mike if he, being an English teacher, knew anything about Hemingway, Mike saw the door to redemption open. He insisted he knew *everything* about Hemingway. The production assistant shuffled him off to a classroom set and asked for a Hemingway blackboard assignment. Mike made up the assignment. But when he started to write it on the blackboard, his dreams of being in the movie, or at least having his *handwriting* in the movie, came to a screeching halt. "Sorry pal. That's a union job."

"Peggy Sue Got Married" left Santa Rosans with fond memories of the movies coming to town. It was one of several that have filmed here, including Disney's "Pollyanna," and Hitchcock's "Shadow of a Doubt." There will be more. But for SRHS in particular, the movie was a very special event. So do yourself a favor. Find a way to view "Peggy Sue Got Married." You'll laugh and maybe cry a little. And as a bonus, you'll get a dose of nostalgia for days spent at good ol' SRHS.

Foundation: With thousands of high schools to choose from, why did you pick Santa Rosa High as a central shooting location for "Peggy Sue Got Married"?

Mr. Coppola: Choosing a location is always a matter of several criteria: where? how practical? how suitable for story? But I can't remember the specifics so many years later.

Foundation: Did you hire many locals as extras?

Mr. Coppola: All of the extras were locals from Santa Rosa and throughout Sonoma Valley. Several hundred locals performed as background talent in the film.... Most of them in 1960s wardrobe and make-up.

Foundation: Did you rent the period cars from Santa Rosans?

Mr. Coppola: Our Transportation Dept. acquired "picture cars" from Northern California owners -- from 1940's-1950's: fire truck to Ford Ranchero, Hudson Hornet to chopped and lowered Mercury, Bel-Air convertibles to Peggy Sue's dad's Edsel.

Foundation: You have been very generous donating cases of wine to our Polenta Feed and Golf Tournament. Why? Santa Rosa High isn't your school.

Mr. Coppola: All schools are 'my' school.

Foundation: You have a reputation for community involvement. Why is community involvement important to you?

Community is like a family and I love my family.

Foundation: Are there any other comments you'd like to add about your "Peggy Sue Got Married" experience?

It turned out to be a sweet and touching film.

THE BARN RAISING

November 5th of this year is the 10th Anniversary of the dedication of the Ammirati Barn, SRHS's On Campus Barn.

The Barn Project was the first big dollar project that the Foundation recognized as a Direct Donation. It led to many more.



At my Class of '68 Reunion in 2003, classmate John Ammirati approached me. He wanted to make a donation in his father's name, which was also John. His father's career was in banking. He specialized in obtaining loans for the agriculture community. So John wanted to see the donation go to an ag need at the school.

Walt Ryan, the school district's Ag Advisory President at the time, and I were happily surprised that John wanted to donate quite a few thousand dollars. We figured it would be money well spent on the Campus Barn. Most of the students in the program were city kids and had no place to raise their animals, except for a number of pens with a covering over them. So we decided to put siding on the area, with an open entrance behind a locked gate. Then lay concrete flooring, and get water, drainage, and electricity to the structure.

But we needed more money. We went out into the ag community to ask for help. Bob Falco '67 and Pete Mazzuchi '54 contacted friends in agriculture and obtained more donations. They also gave me contacts for all of our needs. With their help, we contacted Ag Credit. Ag Credit loved the project and agreed to match the Ammirati Donation.

We received big discounts on siding and roofing materials. Tim Nelson '70 from Pace Supply donated the water and drain needs. We got the concrete at cost along with some donations of free cement with the help of Ron Falco '65 through his employer, Superior Supply. Don Carrillo '64 and Dave Smith '66 donated the concrete labor. Bruce Ballard '66 donated the drainage filtration system. The former Panthers stepped up.

So did the Ag Department. Ag instructor, Lisa Piehl provided students and parents for the labor, including two students and a parent to do the welding.

On the Dedication Day we had the Ammirati Family, John '68, Rob '70, and Judy '72, as well as representatives from Ag Credit and the Farm Bureau, board members of the SRHS Foundation, Ag parents and students, School Board members, and City School officials. A large percentage of the folks who donated money, supplies, and labor to the project were there, too. The Ammarati family cut the ribbon. The Barn was open and so was a new path to helping for the Foundation.






CORRECTION


