SRHS the first 50 years: 1875-1925 by Mike Daniels '59

ed note: The following is an updated version of an article that first appeared in the Summer Issue 1990 Foundation Newsletter, Vol. 2 No. 3

f the many thousands of SRHS graduates could agree on one thing, it would be that SRHS looks like a high school ought to. Its two-story classic brick exterior has impressed Mendocino Avenue passersby since 1925.

To subtract 1925 from 2006 would suggest SRHS is 81 years old, but the school is much older, 129 years in fact. This June, SRHS will graduate its 125th senior class. Why the discrepancy in these numbers? Here's an explanation.

SRHS began a three-year program of study to a student body of 10 in 1875 in three rooms on the upper floor of the John C. Fremont School on Fourth Street. All 10 members of that first class participated in graduation ceremonies in 1878.

The year after that commencement, SRHS was forced to shut its doors. According to local historian Gaye LeBaron, the closure happened because of community disagreement about politics, funding and commitment to education. Within a couple of years, these differences were resolved and classes met again to produce a second graduating class in 1880.

Although the school remained open, that on-again, off-again commencement pattern continued until 1885. Every year since, a senior class has participated in graduation ceremonies.

While the names of the 27 alumni that make up the classes prior to 1885 reflect many of Santa Rosa's early settlers, it is interesting to note that almost 20% of them were from the Crane family who settled on Petaluma Hill Road during the Gold Rush.

In 1886 Fred H. Julliard of the pioneer, fruit-growing Julliard family graduated along with six other students. The family's property was across Santa Rosa Avenue from Luther Burbank's. Today, a part of that property is Julliard Park.

Another member of that small class, Clement Young, is notable for a variety of reasons. He returned to Santa Rosa in 1892 as SRHS principal. He also coached the very first football team—not because he was principal but because he had actually seen a football game while in the East where the game was gaining popularity at the secondary and collegiate level.

Young left SRHS at the end of that year and joined the faculty at Lowell High School in San Francisco, a school noted for its academic emphasis. There, he authored textbooks and worked on curricular matters but soon abandoned education for real estate and politics. He was elected to the state legislature and in 1928 he became the state governor.

By the late 1880s, the Fremont School, popularly referred to as the "Fourth Street School," was literally bursting with students. That school, built in 1866 to replace other, outgrown sites, now needed relief itself. Other schools and districts also had opened, many of their students electing to come to SRHS. These schools included a new school in western Santa Rosa that would become Lincoln School. The new South Park District on Santa Rosa's southern edge and the older Lewis District to the north, plus a number of small, rural schools, all funneled their students into SRHS, also increasing enrollment. The graduating class of 1893 totaled 26, and if the SRHS student body numbered, say, 75 or 100, the impact on the small Fourth Street campus would

have been substantial.

The solution to overcrowding? A new school building for the high school. In 1893 an election approved the need, raised the required capital, and selected a site on Humboldt and Benton Streets because it was the cheapest available.

A handsome, ornate three-story building of native redwood was completed there by the opening of school in 1895. The extra room allowed expansion of the curricula to enrich learning. Students could now conduct science experiments, for example, instead of watching the instructor draw on the chalkboard.

The indomitable Frances O'Meara joined the SRHS faculty when this new school opened. Over the next 45 years she would earn her legendary status in the English classroom and, later, in the study hall as she ensured it was quiet and each student was busily engaged with his or her assignments. For the five years prior to her career at SRHS, O'Meara had taught in Cazadero and in a rural school west of Sebastopol. Her 50 year teaching career was later eclipsed only by that of Eugene DeSoto, who taught 36 of his 51 years in the English classroom at SRHS. DeSoto was equally

The Student-of-the-Month program each year concludes in a dinner, and we had another successful one May 15th at the Druids. Students, parents and family and teachers attended and ate pasta and the students received certificates from the Foundation. We always enjoy the opportunity to interact with students.

Because my term as president is coming to a close, this column is my last, so I want to review the highlights of the last two years: We have given the school over \$200,000 in that time period; installed lights on Nevers Field; continued our wonderful newsletter headed by our newest board member Alicia Hodenfield; added three more board members, Dick Hutchinson and Ann Hutchinson Porrino and Jim Ward, who is our new Treasurer, and will accept former board member Christine Romani Tonelli this summer; developed a fantastic web site (<u>www.srhsf.org</u>), thanks to board member David Thompson; built a new ag barn, courtesy of Chris Zeek and crew; expanded the Polenta Feed to over 600 attendees. We have a dedicated and very capable board and the Foundation offers real stabil-

ity to its members, to SRHS, and to its administrators and staff. Thanks for the memories. It has been fun...

renowned for his knowledge of his subject matter and of his classroom control. Sadly, both respected and revered instructors died shortly after retirement, O'Meara in 1939 and DeSoto in 2003.

Robert Ripley, who gained wealth and world fame as the creator of "Believe It or Not," is certainly one of the most famous non-graduates of Santa Rosa

High School. Ripley did not do well in academic study but had the good fortune to come under O'Meara's tutelage. Instead of



scolding him for drawing, she encouraged him. Instead of requiring written essays, she accepted his art work because she saw it indicated he was familiar with the assigned

Although Ripley left SRHS before his class was to graduate in 1907, he maintained contact with O'Meara, regularly sending her gifts and letters about his career and returning to speak at SRHS. Once, he treated O'Meara to a vacation trip around the world.

C. Raymond Clar, a 1922 graduate who experienced a lengthy career with the California Department of Forestry, rising to the position of State Forester, recalled his freshman year in O'Meara's class, when she "displayed perhaps a dozen neat pen sketches of Elizabethan costumes and related subjects. She explained that these were done by a town boy named Bob Ripley in lieu of writing themes."

In 1912 the graduating class totaled 43 students. Roy Simpson, a member of that class, rose through educational circles to become California State Superintendent of Education in 1951.

Also in 1912, a new building of concrete and steel was constructed just to the north of the 1895 classroom building. This new structure, dubbed "The Annex," had an indoor basketball court and enough room for shop and home economic classes as it

the curricula and helped lessen the crunch of a once again crowded campus. The Annex would become the junior high for a number of years and later Fremont Elementary when the junior high moved to College Avenue when the two schools swapped campuses in 1950. The building's academic life came to an end in the late 1960s when it was scrapped because of fears

an earthquake could tumble it.

Ernie Nevers, another famous nongraduate, brought considerable athletic attention to SRHS in 1920. He moved to Santa Rosa with his family and played baseball in the spring of that year, and football and a few basketball games in the fall before he returned to Wisconsin. On the SRHS gridiron, Nevers led the team to the Northern Section Championship game with Berkeley High, a game SRHS lost but one that reflected a huge turnaround for a program that had lost every game the previous year. Nevers came back to Santa Rosa after high school graduation in Wisconsin and played and helped coach football at SRJC, which began sharing the SRHS campus in 1918. He then transferred to Stanford where he earned II varsity letters in football, basketball, track, and baseball. He played both professional football and baseball. In 1926 the SRHS football field was named in his honor. He was elected to the College Football Hall of Fame in 1951 and to the NFL Hall of Fame in 1963.

just after I Ipm, but by the time firemen arrived the building was beyond saving. The fire consumed the library's books along with furniture and instructional material and all records of the high school, junior college and junior high.

The cause of the fire remains a mystery although a number of theories surfaced once it was extinguished. The Press Democrat treated three in a lengthy story about the fire: defective electrical wiring, chemical explosion and arson.

facetiously because none has offered evidence to support the claim.

Although the cause was never accurately determined. the school board did immediately order an inspection and replacement of defective wiring in the city's other schools and the immediate re-

moval of all kerosene heaters.

For the next four years, SRHS students were forced to troop around downtown Santa Rosa to attend classes in rented and donated space in churches, warehouses, the library and private homes.

Then, for the spring semester of 1925, classes were held in the Main Building, the first building to be completed on the Mendocino Avenue campus. That building's construction was followed, in order, by the auditorium, the gymnasium, the shop building, the Sara Pryor Music Building and Burke Hall, the ag

In his "Remember When – 1976" in the latest SRHS Foundation Newsletter, Rick Blaine writes about the training at SRHS for jobs that did not require college. For girls he mentions the opportunity to learn clothing and other homemaking skills.

Let it not be forgotten that during the 1940s Miss Locke and Miss Penzig taught typing, shorthand, business math, and other secretarial skills that helped women obtain jobs that actually paid money. I don't know how many years before our Class of 1945 that female students were offered this training beyond and along with "college prep" programs, but when women were needed to replace men sent to the front lines, many went to work without the benefit of college.

Secretarial skills taught at SRHS helped to win WW II as well as keep the home fires burning. Does SRHS still offer these courses or the modern equivalent?



to locating donations of materials and labor and coordinating their use. Following is a sampling of campus projects planned and underway.

Phase one of the project to improve campus agricultural facilities is now complete. Many thanks to Ron Cox, who installed the electrical component, and to Dave Hunt, who completed the finish work for the siding and trim.

The next phase of construction will include a combination wash and scale area, a pad a storage shed will sit on and protection for an electrical box.

Another completed project is the sound system on the visitors' side of Nevers Field. A donation by Jerry Poznanovich made possible the installation of wiring and brackets.

Donations by N.A.P.A. and a number of local businesses allow the auto shop program to continue its expansion. Shop instructor Vic Colli has secured vehicles for student use in diagnostic and repair practice.

In the planning stage for this summer is the construction of a monument in honor of Ernie Nevers. It will be located near the flagpole and scoreboard at the south end of Nevers Field. Nevers, before his collegiate and professional accomplishments in football, led SRHS to a championship game in 1920. Rich Peters is donating his services to construct the monument that will be made of brick and will house a plaque designed by Foundation board member David Thompson.

The SRHS Athletic Wall of Fame, to be located in the lobby of the remodeled South Gym, is also still in the planning stage. The experience and knowledge of Foundation board member Jim Ward as president of the SRJC Bearcub Athletic Trust will be helpful to guide the development of this program.




